Andy Dalton gave an update on courses and instructors for the 2015 Conference. Chairman Hrabovsky announced that she and Bernie Howe would do a two part course on photography. The morning session will be on basic photography and camera basics; the afternoon session will be on techniques for nature photography, field application, and photo enhancement with computer software. Several people volunteered to contact proposed speakers and report to Andy.

Sam Muncy announced that he has arranged for Mr. Brickman and Dr. Perkins of the American Chestnut Foundation (TACF) to provide the Friday night opening presentation. They will also conduct a workshop on Saturday morning. They are being supported by the TACF.

Andy Dalton will arrange for a speaker from the Astronomy Club to do a class room session with a "star gazing" component (weather permitting) following the Saturday night Annual Meeting.

Penny Miller will contact Paul Redford about scheduling one of the State Parks for the 2016 meeting.

DNR will handle registration as they have in previous years.
